MILLIONS OF PRISONERS ARE CRAMMED INTO DENSELY CROWDED PRISONS. 95% OF THESE MEN AND WOMEN WILL ONE DAY BE RELEASED BACK INTO SOCIETY. MANY WANT TO CHANGE. YET AN ESTIMATED 70% WILL COMMIT NEW CRIMES AND RETURN TO PRISON WITHIN THREE YEARS. THEY ARE BROKEN, MARGINALIZED AND HIDDEN AWAY FROM SOCIETY. PRISONERS AROUND THE WORLD SUFFER FROM INHUMANE LIVING CONDITIONS AND BROKEN JUSTICE SYSTEMS. THEY ARE INNOCENT VICTIMS OF CRIME. ONE MILLION OF THEM HAVE NO SAFE PLACE TO LIVE AND LACK FOOD, MEDICAL CARE, EDUCATION, AND SPIRITUAL NURTURE.
